The wait list closes Monday July 19. Move ups for Saturday close Monday July 19. After Tuesday at noon no changes can be made to your entry. For Saturday. Please look at your confirmation carefully.

**No setup for exhibitors on Friday. The building will open Saturday at 6:45 am and Sunday at 7 am. Please do not enter the building through the main doors. Entry can be made directly onto the field through the door to the left of the main doors.**

**Move ups will be accepted for Sunday by the end of the trial Saturday.**

**No RV parking on site.**

The club and facility owners are not responsible for lost or stolen items. Crating from your vehicle is at your own risk. Lock your vehicle and remove any valuables.

Tarps or other *waterproof* mats MUST be used under all crates to protect the turf from spills and pet hair. Tarps will be available for purchase from ACSI if you don't have one. Only water and dog treats are allowed on the turf. Please keep all other food and drinks in the concrete viewing and dining areas.

Exhibitors are responsible for cleaning up after their dogs, and exhibitors failing to do so may be excused from the trial without refund.

No grooming is allowed inside the building. Please help us keep the facility tidy by picking up any excess pet hair and trash around your crating space.

All chairs and tables with 4 individual feet must be on a thick woven or rubber mat or rug to protect the turf. Those woven camping mats we all love will do the trick! Chairs with a solid bar for legs may sit directly on the turf.

Remember, this is a public park, not a dog facility. Please help us show the city how awesome dog people can be so we can continue hosting trials at their facility!
